BSA Online Tax Inquiry

All tax records for Midland County are public record. If there is a need to review taxes owed or paid that information can be accessed online. Please note there can be a delay when reviewing recent payments during the tax season because the local township treasurers provide an update bi-weekly to the county treasurer's office. Once those updates are provided the data is reflected online. To look up tax amounts due, delinquent taxes and/or tax payments made one of the following criteria must be known 1) property address; 2) homeowner's name; or 3) parcel tax identification number.

Steps to perform an inquiry:

Access BSA online through the internet at https://bsaonline.com/?uid=314

 This should link directly to Midland County, Michigan – if there is a screen to select the municipality then scroll to find Midland County. If there is a need to confirm you are not a robot, follow the steps as directed.



2. Select the search criteria using the menu option: Address; Name; Parcel Number. A search can be conducted based on partial information, such as only street name or last name.



3. Enter into the search box the applicable information. For example, searching via address, select address from the drop down then input the street address of the property (as shown 737 W. Beamish Rd). If the full address isn't known, type in the information that is known and available properties meeting that criteria will appear. Select a property from the results to review additional details.



4. Clicking on the property in the results will bring up more information, with multiple tabs. The home screen lands on 'Property Information'. Additional tabs of 'Tax Information' and 'Delinquent Tax Information' are also shown.
