Bids will be opened on **Thursday June 20, 2024, by 3:00 P.M.** in the Jerome Township Conference Room of the Jerome Township Hall, located at 737 Beamish Rd. Sanford, Michigan 48657.

Bids received after the due date and time will not be considered.
